

he Eastern Africa Standby Force was established on 16th July 2004 as a regional mechanism to provide capability for rapid deployment of forces to carry out preventive deployment, rapid intervention, peace support operations and peace enforcement. We cannot forget the reason for our creation, which is to carry out in a timely manner the functions of maintenance of peace and security, through a regional conflict prevention, management

he Eastern Africa Standby Force has this year celebrated 10 Years of Partnership with the Nordic Advisory Coordination Staff (NACS). To mark the occasion a commemorative event was held at the EASF secretariat 30th of October 2019, in Nairobi.

Since 2009, the Nordic Countries, including Denmark, Finland, Norway and Sweden have been supporting EASF in building institutional capacities in order to play its role in enhancing

RECSA & EASF, Penning the Accord



memorandum of understanding between the Regional Centre on Small Arms (RECSA) and the Eastern Africa Standby force (EASF) was sealed on 27th November, 2019.

The signing of the MoU between RECSA and EASF follows a previous meeting held in September 2019 between LT.Gen Badreldin Elamin Abdegadir Executive Secretary of RECSA and Dr. Abdillahi Omar Bouh, director of the EASF.

During the signing the two institutions reiterated their desirability of cooperation within the fields of their respective competence of enhancing peace and security in the east African member states including among other things prevention, control and reduction of small arms and light weapons.

There was a previous MoU between RECSA and EASF signed in January 2014 but the implementation was not extensively monitored. In the 2019 MoU

there is a provision for focal persons from each of the entity with the role of ensuring effective implementation of the MoU. Some important areas of cooperation will include; efforts to achieve the best use of all available information relevant to the fight against illicit proliferation of small arms and light weapons in a peace support set up. To cooperate in areas such as demobilisation, disarmament and reintegration (DDR) and other relevant fields with the specific modalities of which will be agreed upon depending on the nature of the mission.

Both LT. Gen Badreldin Elamin Abdegadir Executive Secretary of RECSA and Dr. Abdillahi Omar Bouh, director of the EASF applauded the spirit and revived commitment between the two parties and are hopeful that the new MoU will further strengthen the collaboration between RECSA and the EASF.

In his address to the newly certified IMPP trainers, the course Director who is also the Civilian Advisor at the EASF, Mr. Peter Zartsdahl highlighted the importance of the IMPP course and how the course content has been updated making it more relevant and comprehensive.

According to two participants of the course, Mr. Fred Bamboche and Mr. Steve Lalande, they are now confident and deeply acquainted with the IMPP content and mandating process and more importantly, they are ready to impart their knowledge, skills and competencies to fellow participants from EASF Member States.

Peace Academy in Khartoum, Sudan starting from 14th October 2019.

Just a few weeks after regional facilitators were certified it was time for them to 'face the music' and put into practice what they learnt in through a two-week Integrated Mission Planning Course (IMPC) which took place at the Sudan



It is expected that this training will contribute to increasing the number of individuals held on the Deployment and Readiness Roster (D&RR) and who are competent in Integrated Mission Planning Process, thus enhancing the operational effectiveness of EASE.

Preparing civilians

Civilian staff members perform many of the mandated tasks of peacekeeping operations: promoting and protecting human rights, helping strengthen the rule of law, fostering political and reconciliations processes, promoting mineawareness, and serving as public information officers who explain and build support for the peace processes and help to build the credibility of any peace support mission. EASF pays particular attention to the civilian component and the role of civilians in peace support missions is paramount.

Civilians also serve in many support capacities in the areas of finance, logistics, communication and technology (ICT), human resources and general administration to help missions promote peace and security. A group of excited and motivated civilians form EASF member states arrived at the Jomo Kenyatta International airport in November this year, eager and ready to participle in the third and last Civilian Foundation Course for 2019.

The Civilian Foundation Course is a mandatory training considered a prerequisite for deployment of civilians in any Peace Support Operations rolled out by either EASF or the African Union. It also examines structural and specific functional units in peace operations, mission mandates and lessons learned from previous missions.

The Civilian Foundation course had twenty-six participants from nine counties of EASF Member States including Burundi, Comoros, Djibouti, Ethiopia, Kenya, Rwanda, Seychelles, Sudan and Uganda.

EASF Maritime Cell Search and Rescue Course



he year 2019 was very successful EASF Maritime cell with numerous courses and training sessions organised.

One of the recent training courses was a two week Maritime Search and Rescue course (SAR) held in September in Entebbe, Uganda.

The aim of the course was to train and equip naval, coastguard officers and maritime rescue coordination centers (MRCC) Staff with skills and competencies needed to respond to any emergency at sea.

EASF Director Dr. Abdillahi Omar Bouh, appreciated the commitment and support of the Member States to have well trained and ready multidimensional regional force which can deploy under any condition at any time if needs come.

The course was composed of 24 participants from Burundi, Comoros, Djibouti, Kenya, Somalia, Sudan, Uganda and EASF Maritime Cell as well.

Emma Ng'ang East Africa's Youth Ambassador

he African Youth Ambassador Programme (AYAP) is a pivotal element of the peace and security department under the AU. Following the call for application for youth ambassadors for the continent over 1700 applications were received out of which 15 candidates were shortlisted, three from each region. For the East Africa three youth candidates were contesting for the position namely; Emma Ng'ang from Kenya, Cristopher Morris from Tanzania and Ifrah Farah from Somalia.

After intensive assessment and interviewing process Ms. Emma Ng'ang from Kenya was nominated as the Youth ambassador for the eastern region and together with the youth

ambassadors form the other four regions they were instituted by the PSC at the AU Headquarters, in Addis Ababa. EASF was represented at the event by its youth focal person to AU, Mr. Jules Hoareau.

The EASF would like to congratulate Ms. Emma on her appointment as the region's youth ambassador and offers its full support to Emma in the promotion of youth, peace and security in Africa.
